AFM Kenyan ministries is our largest financial ministry focus. Through our commissioned missionaries Jeff and Stephanie Bys, we have further developed our discipleship ministries through taking in and caring for orphans and at risk children in our Mercy Children's Home program. We have acquired more land and improved our home campus to better help us serve the needy of the region. Furthermore we focused also on pastoral training, Bible study classes for church leaders and growing our influence in the community for sound biblical doctrine through our Neema Baptist Church ministry. Along with these ministries we have helped the community poor and widows with feeding programs and helping some with home restorations. In 2018 we also supported many Kenyan pastors with Bibles and Gospel tract publications for outreach, as well we supported but phased out support of our prior Samson orphan ministries due to accountability issues thus bringing more control of how funding is best used from donors with more integrity.

4b (Code:) (Expenses \$ 44,104 including grants of \$ 50,903) (Revenue \$ 6,799)

Jim Ball discipleship ministry. AFM supports and facilitates Jim's funding of his mission to reach the unreached people groups with the Gospel of Jesus through his activities of missionary work in Asia as well as teach and promote reproducible discipleship training here in the USA to help others grow the Church Biblically in north America also. These expenses represent his income and costs of carrying out his missionary work over the past year of 2018 including Mission trip costs and any carry over revenue.

A growing part of AFM Ministry work has also been in Philippines as we have worked to better fund pastor Romeo and his associated pastors all of whom struggle for basic survival as they pastor small Baptist mission churches among the poor of Mindanao Island of the Philippines. We funded more Bible tract and Bibles than any year before and have help meet many medical, food and shelter care needs of pastor Romeo and pastor Samonte and the various associates of Romeo. We have continued to fund monthly pastor Christopher Samonte who steadily disciples many in Christian truth and life and helped support he and his wife's goals to get degrees and certifications so they can begin a Christian school in the near future. about 13k went towards funding Romeo and his associates and another 4.6k towards Samonte.
